Paying for information

We will notify you of any charges before fulfilling your request.

Right to refuse a request

Requests may be refused if:

- The cost of compliance would exceed the statutory cost limit
- The request is vexatious or repeated
- Information is exempt under the Act

If a request is refused, we will provide:

- The exemption applied and justification
- Public interest considerations (where applicable)
- Your right to complain to the Information Commissioner's Office

Refusal notices will be issued in writing.
