1. Aims

The aims of relationships and sex education (RSE) at Sun Hill Junior School are to:

- > Provide a framework in which sensitive discussions can take place, and in which children can develop the skills in order to express their own views and listen to the views of others.
- > Ensure that children understand how to keep themselves and others safe
- > Develop the personal skills needed by pupils for them to establish and maintain relationships, to recognise what a healthy relationship looks like, to form healthy relationships, ensuring respect and dignity for themselves and others
- > Explore how to live well together, including behaving well towards others, disagreeing well, forgiving and repairing broken relationships
- > Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- > Help pupils develop feelings of self-respect, confidence and empathy
- > Create a positive culture around issues of sexuality and relationships
- > Teach pupils the correct vocabulary to describe themselves and their bodies
- > Enable children to make responsible and informed decisions about their health and well-being

Our school STAR values are entwined within everything we do each and every day at Sun Hill Junior School and therefore within relationships and sex education, our children are encouraged to Strive, Trust, Aspire, be Resilient and Support one another within their learning.

2. Statutory requirements

As a primary academy school we must provide relationships education to all pupils as per the *DfE statutory guidance published in 2020* under the Children and Social Work Act 2017. This policy is underpinned by *Relationships Education, Relationships and Sex Education (RSE) and Health Education – Statutory Guidance*. This policy will be updated in September 2026 to take in to account the 2025 guidance We do not have to follow the National Curriculum but we are expected to offer all pupils a curriculum that is similar to the National Curriculum including requirements to teach science which would include the elements of sex education contained in the science curriculum. In teaching RSE, we are required by our funding agreements to have regard to *guidance* issued by the secretary of state as outlined in section 403 of the *Education Act* 1996. At Sun Hill Junior School we teach RSE as set out in this policy.

3. Policy development

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

- 1. Review The PSHE/RSE lead pulled together all relevant information including relevant national and local guidance
- 2. Local governing body
- 3. Staff consultation
- 4. Parent/stakeholder consultation A presentation was made available to parents on the website detailing changes and they were invited to discuss any points.
- 5. Pupil consultation
- 6. Ratification once amendments were made, the policy was shared with trustees and ratified

4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity. RSE involves a combination of sharing information, and exploring issues and values. RSE is not about the promotion of sexual activity.

5. Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary.

We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. The curriculum is age appropriate, inclusive and accessible to all pupils including those with SEND. Our curriculum content is based on resources provided by the PSHE association and reflects the mandatory content areas: Relationships Education, Health Education and statutory sex education. Teachers will use the objectives and always take into account the needs and feelings of our pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

Primary sex education will focus on:

- > Preparing boys and girls for the changes that adolescence brings
- > How a baby is conceived and born

6. Delivery of RSE

At Sun Hill Junior School RSE is taught within the personal, social, health and economic (PSHE) education curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE).

Relationships education focuses on teaching the fundamental building blocks and characteristics of positive relationships including:

- > Families and people who care for me
- > Caring friendships
- > Respectful relationships
- > Online relationships
- > Being safe

Our school follows the Christopher Winter Project resource (endorsed by the PSHE Association) to deliver the non-statutory element of the RSE curriculum. For more information about our RSE curriculum, see Appendices 1 and 2. These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

Teaching will promote equality and respect for all families and identities, be sensitive to pupils' backgrounds and experiences and support safeguarding and pupil wellbeing.

SEND

At Sun Hill Junior School Relationships and Health Education is accessible for all pupils. We provide high quality teaching that is differentiated and personalized to ensure accessibility. Resources and delivery methods are adapted to meet individual needs.

7. Roles and responsibilities

7.1 Trustees

The trustees will approve the RSE policy, and hold the headteacher to account for its implementation.

7.2 The headteacher

The headteacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory/non-science components of RSE (see section 8).

7.3 Staff

Staff are responsible for:

- > Delivering RSE in a sensitive way
- > Modelling positive attitudes to RSE
- Monitoring progress
- > Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the non-statutory/non-science components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the headteacher.

The curriculum leader with the PSHE curriculum coordinator will:

- develop a differentiated PSHE / RSE curriculum;
- * work closely with subject coordinators in Science, Computing R.E and P.E. to ensure Relationships Education, Sex Education and Health Education do not duplicate content covered in the National Curriculum;
- * work with external organisations in order to enhance delivery of these subjects by introducing specialist knowledge and different ways of engaging with pupils;
- ensure that the teaching delivered by a specialist teacher fits with the planned programme;
- A provide strategic leadership and direction;
- * provide a curriculum that provides pupils with the essential knowledge they need to be educated citizens in democratic Britain;
- A promote an awareness of and respect for a diversity of cultures, values, beliefs and abilities;
- ensure appropriate coverage of the curriculum;
- provide support and advice;
- monitor pupil progress in this area;
- . ensure sufficient and up to date resources are in place
- provide guidance and support to all staff;
- ♣ make effective use of relevant research and information to improve this policy;
- ♣ keep up to date with new developments and resources;
- * review and monitor the implementation of the policy and curriculum;

7.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

8. Parents' right to withdraw

Parents do not have the right to withdraw their children from relationships or health education. Parents have the right to withdraw their children from the non-statutory/non-science components of sex education within RSE. Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the headteacher. Alternative work will be given to pupils who are withdrawn from sex education.

9. Training

Staff are trained on the delivery of RSE as part of their induction and it is included in our continuing professional development calendar. The headteacher will also invite visitors from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE.

10. Monitoring arrangements

The delivery of RSE is monitored by the PSHE/RSE subject lead and the Headteacher through: learning walks, child conferencing/ pupil voice and work sampling in order to evaluate effectiveness.

Pupils' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by PSHE coordinator and curriculum leader annually and updated in line with statutory changes. At every review, the policy will be approved by the headteacher and the board of Trustees.
